Introduction to the Voter Guide

Church Voter Guides is an independent 501(c)(3) faith-based nonprofit organization. We serve the public by providing objective research and education on matters specifically of interest to Christians, primarily through the production and distribution of 501(c)(3)-compliant, nonpartisan Voter Guides.

Church Voter Guides does not endorse or oppose any candidates for public office or any political party.

Church Voter Guides, a Tennessee nonprofit, initially started in Colorado Springs in April of 2021. This new Voter Guide for the 2026 Republican General / Primary is being distributed electronically-only through our website via downloadable and printable PDF files, as well as mobile-friendly interactive webpages. We have produced one Voter Guide for each seat that is: (1) conducting a contested election this year, and (2) for which at least one candidate in that election answered our Questionnaire. Our Voter Guides are being promoted through a wide-ranging network of area churches, faith-based non-profit organizations, mainstream and social media, and other means.

The purpose of our Voter Guides is to educate and inform voters of each candidate's positions on a variety of policy issues that they are likely to address if elected, as well as information on Ballot Measures. As a Voter Guide designed to be distributed through Churches, we ask the candidates questions on topics that are of utmost interest to the Christian voter.

How to Get the Most Benefit from this Voter Guide

The core information in this Voter Guide comes directly from the candidates themselves. We asked them questions, they answered (with a 120 word limit), and we have published their responses here verbatim. In order to understand and utilize this information to the fullest, so that you may vote in the most informed way, we suggest the following:

1. Pray and ask the Almighty for discernment. The Kingdom of God is all about truth, while politics is a system fraught with compromise. Make sure you consider the candidates' answers with a Heavenly mindset.
2. Ask yourself, "Did the candidate actually answer the question, or rather side-step it, or give a fluff, wishy-washy, and/or 'political' type answer that leaves you not really knowing where he/she truly stands on the issue?"
3. Learn more about the candidates running for Republican Primary & General Candidates, including their positions on issues we did not cover in our questionnaire, by visiting their official campaign websites (if they have one.) The website URL for each candidate is listed in the Voter Guide.
4. Educate yourself more about the Christian/Biblical perspective regarding many of the subjects covered in our Voter Guide by reading topical articles on our website: www.VoteChattanooga.org
5. Use search engines to find additional information about each candidate, including written articles and videos, other voter guides, and even voting records for those who have served in public office before. You may even want to watch online recordings of the local Republican Primary & General Candidates meetings to see how incumbents conduct themselves and vote.
6. Reach out to the candidates themselves through the provided email addresses and other means, in order to ask them questions of personal importance to you. Please make sure to show great respect toward each candidate and his/her time, especially to those with whom you disagree. Running for office is hard, stressful, time consuming work, and these are your fellow citizens who have lives, families, jobs...and feelings (just like you!)

What makes a Voter Guide 501(c)(3)-compliant and Nonpartisan?

Federal tax law permits nonprofit 501(c)(3) organizations to develop and distribute materials about political candidates' positions on issues, in order to educate voters impartially and on a nonpartisan basis; meaning that it is free from party affiliation, bias, or designation. The IRS states that 501(c)(3) organizations may conduct any range of activities to promote voter participation and educate voters so long as it is nonpartisan. But, 501(c)(3) organizations are explicitly prohibited from supporting or opposing candidates for public office or political parties.

Some of the activities 501(c)(3) nonprofits *MAY* perform: Conduct or promote voter registration; educate voters on the voting process; distribute nonpartisan sample ballots, candidate questionnaires, and **voter guides**; organize get-out-the-vote activities; encourage and help people to vote; educate the candidates on issues important to their organization; and continue to do issue advocacy during an election.

So, first and foremost: **Church Voter Guides** does **NOT** endorse or oppose any candidates for public office or any political party.

Second, all of our staff and volunteers are required to act in a nonpartisan manner when working for or representing the organization and the creation of the Voter Guide.

Third, we do not edit, revise, or editorialize candidate responses to our Questionnaire. We do not even correct typos. **Candidate answers are published verbatim**, ensuring that their responses accurately represent their positions and perspectives on these issues. We then simply share this information through the Voter Guide, and you decide whom you believe to be the best candidate.

To be fair and impartial, we reached out by email, text, and phone when determined necessary, to all registered candidates running for Republican Primary & General Candidates throughout Hamilton County / Tennessee for their 2026 elections, inviting them to answer our questionnaire. Candidate information is presented in alphabetical order by **last name**. If a Candidate did not respond at all, or did not choose to participate, or did not choose to respond to certain answers in the questionnaire, then it is noted where applicable. If there were not enough candidates running, then we did not produce a Voter Guide for that seat.

1) Purpose: What do you view as the purpose and role of the County Commission?

The role of the County Commission is to serve the people through responsible, transparent governance. This includes setting priorities for taxpayer dollars, supporting public safety, public schools, infrastructure, and strong communities.

It is equally important that the Commission operates as a unified body, grounded in clear values and a shared mission. Each decision should begin with a simple question: how does this serve the best interests of our residents?

Our priorities remain clear—protecting strong family values, preserving the beauty of our environment, and maintaining the character of our community. We are accountable first and foremost to the people we serve, not outside interests.

2) Candidate's Focus/Expertise/Initiatives: What are your areas of special focus and/or expertise and what initiatives would you undertake as County Commissioner?

My focus is on responsible growth, strong infrastructure, and being a committed advocate for public education. A strong school system provides the foundation for young people to become capable, contributing members of our community.

Investing early—especially in underserved areas—creates opportunity, guidance, and long-term stability. When students have support and mentorship, they are more likely to pursue meaningful, productive paths.

I also see a strategic opportunity in leveraging our position as Gig City to attract employers with a strong WORK FROM HOME workforce. This allows graduates to remain in Hamilton County while accessing broader career opportunities. To support this growth, we must ensure affordable housing, transportation, and infrastructure are in place.

3) Budget: What would be your top three spending, savings, and economic development priorities?

My top priorities are:

1. Infrastructure investment: Roads, water systems, and emergency services must be funded first, with growth tied to capacity so we avoid costly repairs and delays later.
2. Responsible budgeting: Careful stewardship of taxpayer dollars, focusing on long-term savings, reducing waste, and prioritizing essential services while maintaining strong reserves.
3. Strong schools: Supporting education as a long-term investment in our workforce and community, helping develop responsible, capable citizens prepared for the future.

Growth can be expensive, and that burden should never fall on existing residents. Developers must take responsibility for the true cost of new growth. Decisions should reflect long-term fiscal responsibility—not short-term gain.

4) Constitutional Liberties: As County Commissioner, what measures will you champion to protect the individual Constitutional liberties of all Hamilton County residents, such as freedom of speech, peaceable assembly and exercise of religion?

Protecting Constitutional liberties is essential to a just and inclusive community. I will support policies that uphold freedom of speech, peaceful assembly, and religious expression, while also ensuring equal protection under the law for all residents. These rights must be applied consistently—not selectively—and the Constitution should always serve as our guiding framework.

Good governance requires transparency, accountability, and fairness so every voice can be heard. People should feel both protected and empowered to exercise their rights. My role is to help foster a community rooted in respect, dignity, and a shared commitment to upholding these freedoms for everyone.

5) Protecting Life: What legal means, if any, would you support to protect the most vulnerable in our county, including the lives of the unborn, the trafficked, the poor and homeless, and the elderly?

Protecting the most vulnerable is both a moral responsibility and a reflection of our shared values. I believe every life has inherent worth and dignity. At the county level, that means strengthening families, supporting those in crisis, and ensuring the elderly, homeless, and vulnerable are treated with compassion and care.

We must also remain vigilant in addressing human trafficking through strong partnerships with law enforcement and community organizations. From a faith perspective, we are called to care for one another—especially those most in need. My focus will be on practical support, safety, and restoring hope so individuals can move toward stability and a better future.

6) Moral Values: Should government laws, ordinances, regulations, etc. follow the moral principles of the Ten Commandments? Why, or why not?

Moral principles have long helped shape both our laws and our understanding of right and wrong. The values reflected in the Ten Commandments—honesty, respect for life, personal responsibility, and treating others with fairness—offer a meaningful moral foundation, including respect for all people.

In my experience attending churches across Hamilton County, I've seen these values truly lived out. When they are modeled by churches, families, teachers, and community leaders, they become far more impactful—especially for young people—than simply being displayed in writing.

Because people come from different backgrounds and beliefs, I believe it is more meaningful to live these values with integrity than to require their display.

7) Speed cameras: How would you address the use of automated speed cameras within the county (including those in school zones)? What oversight and transparency measures should be required to maintain public trust? Do speed cameras contradict constitutional protections within drivers' rights such as due process and the right to confront one's accuser?

Public safety, especially in school zones, is essential—but it must be balanced with fairness, transparency, and constitutional protections. When we are in school zones and areas where children are present, the priority is simple—we slow down and protect our students.

Strict oversight should include clearly marked signage, routine accuracy testing and calibration of equipment, public reporting on how many citations are issued and how revenue is used, and a simple, fair process for residents to challenge tickets.

Any enforcement must fully respect due process. The goal should always be safety—not revenue—and policies should reflect that clearly.

8) Zoning/Planning: What policies would you support to prevent and disclose potential conflicts of interest between developers and members of Hamilton County's zoning and planning committees, and how would you ensure that land-use decisions are made transparently, ethically, and in the best interest of residents rather than private interests?

Zoning and planning decisions should reflect why people choose to live here—the natural beauty, the sense of community, and the quality of life. We have a responsibility to be good stewards of our environment, protecting our land, water, and wildlife as we grow.

I believe planning committees should include knowledgeable representatives from each district who understand their communities and work alongside county commissioners—not developers—to ensure current residents are always the priority.

Responsible growth means thoughtful, transparent decisions that protect both our communities and the environment we are entrusted to care for.

9) Managing County Growth and Infrastructure: What strategies and/or resources does the county currently have to better pace growth in Hamilton County so infrastructure, roads and emergency services can keep up with development? How would you use these tools to address this issue?

Hamilton County already has important tools—zoning regulations, planning reviews, and infrastructure assessments—but the key is using them proactively, not reactively. Growth should be tied to capacity, meaning development moves forward only when roads, emergency services, and utilities can support it.

I would support better coordination between planning and infrastructure timelines, along with evaluating traffic, emergency response times, and service availability before approving major developments. Growth should also include family-focused amenities, support for small businesses, and thoughtfully planned communities that consider quality of life.

Responsible, well-paced growth ensures our county remains a place where families and businesses can thrive together.

10) Planning for Unincorporated Areas: Do you support having a separate planning commission for the unincorporated areas? Please explain your reasoning, and if applicable, what steps you would take.

Creating a separate planning commission for unincorporated areas may sound helpful, but it also brings challenges—we are one Hamilton County, and our planning should reflect that unity.

My preference is to maintain a single countywide planning commission while expanding its structure to ensure strong local representation. Members should be assigned by district, with a responsibility to truly know their area—visiting communities, listening to residents, and understanding local needs.

This way, when a project is presented, the assigned member can speak with real insight and firsthand knowledge of the area, rather than relying solely on information provided by developers. That leads to more balanced, informed decisions that reflect the community.

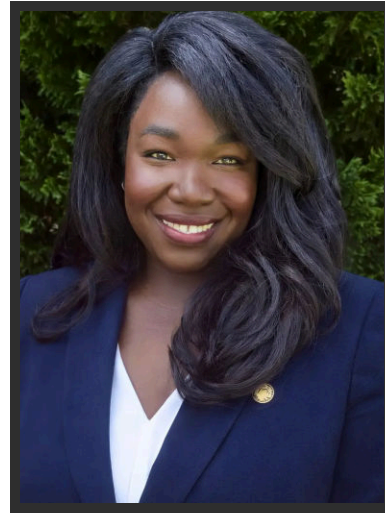

1) Purpose: What do you view as the purpose and role of the County Commission?

As the legislative body of the County, our job is to work closely with the executive office to oversee the budget and operations of Hamilton County. With over 40 years in management, I bring a strong business acumen to the Commission, where others do not. Having run hospitals, events, and now teaching management, I bring a strong business perspective.

As a County Commissioner, not only do I oversee the business aspect of the County but I am also a problem solver. When my constituents have issues, my job is to get them resolved. This is a great strength of mine.

2) Candidate's Focus/Expertise/Initiatives: What are your areas of special focus and/or expertise and what initiatives would you undertake as County Commissioner?

I have spent 40 years in management. With a Master's in Hospital Administration, I spent the first 20 years of my career in that field. My last position, in that field, was the Administrator of Children's Hospital at Erlanger. I changed careers in 1999 and ran the Riverbend Festival (and other events) for the next 20 years. For the past 7 years, I have taught management to our future community leaders.

These experiences have allowed me to use my management expertise to lead our County with over a \$1 billion budget. We have a myriad of issues and opportunities (e.g. safety, schools, infrastructure) that allow me to use these skill sets to proactively help Hamilton County

3) Budget: What would be your top three spending, savings, and economic development priorities?

I have a strong relationship with the Chamber of Commerce. The greatest opportunity to assist them would be with Enterprise South, Broad Street and the Bend developments.

We have spending needs in infrastructure such as roads (\$150 million) and sewers (\$500 million). A better plan needs to be developed by our executive arm.

Savings can be achieved through better economies of scale. A current opportunity is how we coordinate between the hotel/motel tax dollars and how we leverage these with opportunities with the Chamber of Commerce, Tourism Board, Convention Center and all associated attractions. This will allow us to better market our community for business and visitors, allowing our hotels and attractions to flourish

4) Constitutional Liberties: As County Commissioner, what measures will you champion to protect the individual Constitutional liberties of all Hamilton County residents, such as freedom of speech, peaceable assembly and exercise of religion?

Constitutional liberties are paramount to our way of life. We must maintain these liberties in all forms, including freedom of speech, appropriate assembly, and religious freedom. There can be no compromise. For instance, before each Commission meeting, we have a prayer, that anyone has the opportunity to do. I support Sheriff Garrett and what he is doing to keep our community safe. I was integral in the development of Hamilton County jail (eliminating for profit Core Civic) with both Sheriffs Hammond and Garrett.

5) Protecting Life: What legal means, if any, would you support to protect the most vulnerable in our county, including the lives of the unborn, the trafficked, the poor and homeless, and the elderly?

I was the Administrator of Children's Hospital at Erlanger. My wife, Karlette, and I have 4 children. There is nothing more important than for us, as adults, to protect them. They look to us to take care of them and provide for them. The elderly, similarly, are due our respect and need us to do anything possible to honor their lives. They blazed the trail for us and are worthy of anything we can do to assist them.

I worked with Senator Corker on their emphasis on trafficking.

Lastly, I have a strong relationship with the City of Chattanooga and the Chattanooga Foundation on how we take care of the homeless population.

6) Moral Values: Should government laws, ordinances, regulations, etc. follow the moral principles of the Ten Commandments? Why, or why not?

I am a Christian and believe in the Ten Commandments. To me, it starts with honoring my father and mother who were the best role models I have ever had. I hope and pray that I have been even half of that to our children. I think Karlette and I did pretty well in that category, though!

Even though there might be government restrictions, in most cases, it is still possible to let the Ten Commandments prevail in everything we do.

7) Speed cameras: How would you address the use of automated speed cameras within the county (including those in school zones)? We have \$150 million in roads needs and \$500 million in sewer needs. There needs to be a better coordinated effort between builders, roads, sewers, schools, fire, EMS, police/sheriff to make sure that we have all the needed services to sustain the growth we need to remain a strong community.

I set up a meeting last year with the RPA, Chamber, Realtors, Homebuilders, Public Works, Schools Administration and others to address this. This cannot be solely driven by the Commission as all other entities need to want to be at the plate. I will not let this need be exhausted by those who do not see the need or care.

10) Planning for Unincorporated Areas: Do you support having a separate planning commission for the unincorporated areas? Please explain your reasoning, and if applicable, what steps you would take.

About 80% of the Regional Planning Committees decisions are based on the City of Chattanooga needs. When looking at their Board composition, they are heavily represented by the development/sales/architect community. The Board composition should be more balanced.

With only 20% of their decisions based on unincorporated Hamilton County needs, the Board should be more representative of that market. A separate planning commission would help with that disparity.

After a defined period, if residents still feel their needs are unmet, then creating a separate planning structure should be revisited, with a clear plan for how it would function independently and collaborate regionally. We need a measured approach, not a knee-jerk reaction that creates new challenges.

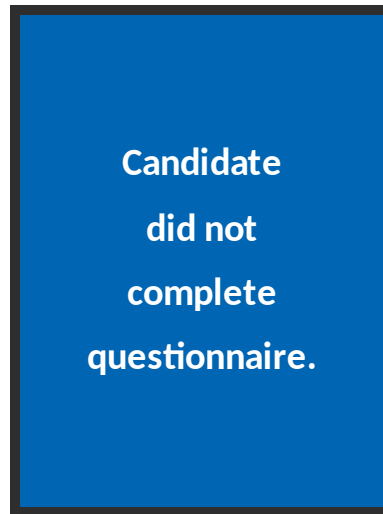

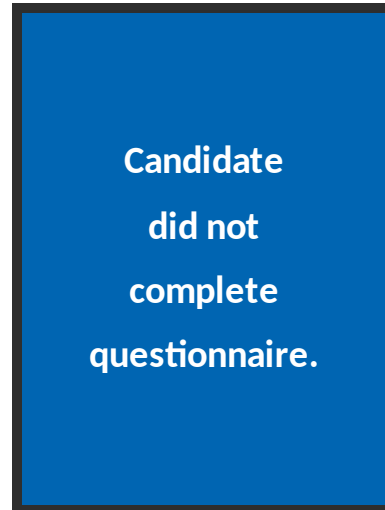

On development, I believe growth should serve residents by providing the necessary infrastructure to support projects, bringing quality jobs that pay a living wage and creating real opportunity for young people to build a life here in Hamilton County, rather than having to leave it. Our development should work for us not the other way around.

3) Budget: What would be your top three spending, savings, and economic development priorities?

My top spending priorities would be affordable and workforce housing, community infrastructure that serves all residents and resources to support our schools and teachers. These investments directly impact quality of life and are fundamental for sustainable growth. On savings, I will inherit a budget I had no hand in approving, so my priority will be to closely examine and responsibly audit it to ensure the next budget fully encompasses the needs of my constituents. For economic development, I envision development that is planned responsibly so growth pays for itself rather than burdening existing taxpayers, attracting quality jobs that pay a living wage, and emerging industries that strengthen our economy while preserving the Hamilton County we all love.

Commissioners also provide oversight of county departments and make policy decisions that affect infrastructure, public safety, and county services. In short, the role is to balance responsible growth, fiscal discipline, and quality of life for the people we represent.

2) Candidate's Focus/Expertise/Initiatives: What are your areas of special focus and/or expertise and what initiatives would you undertake as County Commissioner?

My professional background is in engineering and technology leadership, so I bring a strong focus on data driven decision making, transparency, and accountability. My initiatives focus on infrastructure improvements, responsible growth in the unincorporated areas, and making sure county investments, particularly in roads and schools, keep pace with our growing population.

3) Budget: What would be your top three spending, savings, and economic development priorities?

First, infrastructure investments, especially roads and public safety, to keep up with growth. Second, responsible budgeting that avoids unnecessary tax increases while protecting core services. Public meetings, open records, and clear review processes help ensure land use decisions are made based on the interests of residents rather than private influence.

9) Managing County Growth and Infrastructure: What strategies and/or resources does the county currently have to better pace growth in Hamilton County so infrastructure, roads and emergency services can keep up with development? How would you use these tools to address this issue?

The county uses tools such as zoning authority, infrastructure planning, and coordination with the planning commission to help manage growth. The key is ensuring that development decisions consider road capacity, public safety access, and school infrastructure. Responsible growth requires aligning development approvals with the ability of infrastructure to support it.

10) Planning for Unincorporated Areas: Do you support having a separate planning commission for the unincorporated areas? Please explain your reasoning, and if applicable, what steps you would take.

Yes. The priorities and challenges in unincorporated Hamilton County are often different from those inside the City of Chattanooga. A planning structure that better reflects those differences can help ensure residents in the unincorporated areas have a stronger voice in how growth and development are managed in their communities.

Education and affordability are the two issues that shape nearly every conversation I've had with residents. Our children deserve schools that meet their needs and a county that can sustain them after graduation. That means listening to teachers, funding classrooms responsibly, and ensuring families can afford to live and work here. When parents are forced to work multiple jobs just to get by, children lose the support they need at home — and that affects their future. I've also heard deep concerns about the mishandling of our health department. I want to expand essential services, not dismantle them, because strong communities require strong public health.

3) Budget: What would be your top three spending, savings, and economic development priorities?

My budget priorities center on responsible investment and long-term planning. For spending, I will prioritize education, public safety, and infrastructure — the foundations of a thriving county. Savings should come from a fiscally responsible administration that collaborates across departments and communities, ensuring tax dollars are used transparently and effectively. For economic development, we must manage growth sustainably so it doesn't outpace our ability to support it. That includes thoughtful planning for assets like McDonald Farm, investing in infrastructure such as sewer capacity, and addressing inflated administrative budgets that divert resources away from frontline services. I will push the county to contribute meaningfully to these efforts, especially for unhoused residents and those who have been neglected. When it comes to reproductive rights, the law is set at the state level, but I believe we cannot impose ethics on others without being willing to support the outcomes. (i.e. paid parental leave, healthcare, free and reduced meals) We must invest in our health department and offer assistance - not punish people for systemic failures.

My moral compass is shaped by my faith, but the government must serve everyone — not just those who share my beliefs. Many principles in the Ten Commandments align with existing laws, but freedom of religion requires that no single faith guide our policies. Life is more complex than a list of rules, and governance must make room for people's lived experiences. My decisions will be grounded in integrity, but the role of government is not to enforce religious doctrine. It is to uphold the Constitution, protect individual freedoms, and ensure that every resident — regardless of belief — is treated with fairness and respect.

7) Speed cameras: As mayor, will you continue to enforce speed cameras in school zones and residential areas throughout the county? If so, what oversight and transparency measures should be required to maintain public trust? Do speed cameras contradict constitutional protections within drivers' rights such as due process and the right to confront one's accuser?

Right now, speed cameras function more as a weak revenue stream than an effective safety tool. They issue tickets without meaningfully slowing traffic, and that doesn't build trust or improve safety. I believe we can do better. Any approach to traffic calming should involve community input. Instead of relying on automated enforcement, we should explore design-based solutions and neighborhood-driven ideas that actually make roads safer for children and families (i.e. trees/light poles/planters, raised medians/crosswalks, dedicated pedestrian or bike lanes, roundabouts)

Growth should benefit neighbors, not just large developers. Equal opportunity, clear disclosure, and strong guardrails are essential to restoring fairness in our planning process.

Welcoming the stranger is a direct expression of faith, and how we treat the vulnerable is how we treat Christ Himself (Matthew 25:35-40)

My approach will be grounded in respect for families, clarity in enforcement, and a commitment to ensuring that no community feels singled out or politicized.

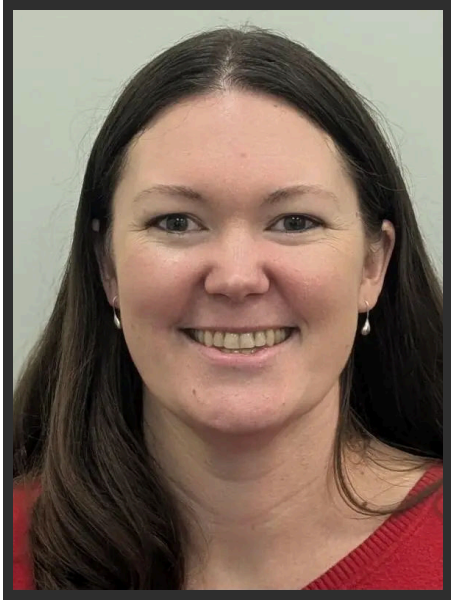

One area for improvement in budget management is evaluating which administrative positions are essential and making thoughtful decisions about reducing roles at the central office. We need competitive pay to attract and retain high-quality employees, along with clear expectations for each role and regular performance reviews. Substitute teachers should receive fair hourly wages. Teachers provide the greatest value within a school, and funding should demonstrate this. Decreasing individual principal-level spending autonomy, while increasing district-wide standardization, could help ensure that all Hamilton County students have equal access to educational opportunities. By making strategic choices about technology—focusing only on tools that genuinely enhance students' ability to become effective citizens—we can minimize unnecessary expenses and improve overall efficiency.

6) Preventing School Violence: In the aftermath of the 2023 Covenant School tragedy, Tennessee has strengthened school safety laws, but many parents continue to express concern in this area. What additional strategies or policy changes would you support in Hamilton County to prevent school shootings, foster community well-being, and protect the rights of students and staff?

Students and teachers should be able to expect safety in the classroom. All threats of violence should be taken seriously, whether they are written, verbal, or physical. All staff should be trained in standard safety protocols. Parents should be informed whenever protocols are enacted. School safety can be improved by allowing schools to enforce discipline effectively from the first offense. Returning to behavioral systems with clear, consistent, and tangible expectations and consequences can help students develop appropriate behavior from a young age. Consequences should be proportional to the offense and serve as a deterrent to repeated behavior while requiring parental involvement. Self-harm threats should receive mental health support facilitated by parent action to ensure the safety of all.

7) Sex Ed Instruction: How should the Hamilton County school district select and source materials for sex education? Should this instruction be provided in schools, strictly at home, or a combination of both? Which organizations, if any, do you believe should be restricted from providing materials, and what is your rationale?

I do not believe that sex education should be taught in Hamilton County schools beyond basic anatomy and physiology. Sex education should begin at home at a young age by teaching children the correct names for their body parts. As children grow, these conversations should continue in an age-appropriate way, guided by parents or guardians. Each family's perspective on healthy boundaries and sexuality is unique, making it difficult for schools to teach this subject in a way that fully respects those differences. For families who need support in this area, public health topics—such as abuse prevention, STI prevention, and healthy relationships—can be addressed by providing resources for parents to review and discuss with their children at home.

8) Racial equity: How should the school district approach teaching racial equity, and what role, if any, should diversity, equity and inclusion play in the curriculum?

Many students already live lives filled with diversity of thought, race, and gender. We should teach civil rights history in history classes and strive to respect others on all occasions. No amount of formal DEI instruction is going to change a person's heart, but loving every student well and ensuring that each student is taught and treated with respect implicitly models the concepts that formal DEI instruction aims to promote. To formally teach DEI without living a life that respects all individuals as uniquely created for a purpose on purpose is a disservice to all students. Formal DEI instruction can sometimes create a culture of shame and stereotyping, disregarding individual uniqueness. Everyone is entitled to basic human rights.

9) Instruction of LGBTQ Issues within Schools: How should Hamilton County schools approach teaching topics related to LGBTQ issues?

LGBTQ issues should not be addressed in Hamilton County Schools. There is no nationally agreed-upon consensus on all topics related to LGBTQ issues, which means that teaching these topics runs the risk of encroaching on parental liberty and instructing individual students in ways that may be counter to their families' belief systems. School systems also lack the time and resources to adequately teach the basics and are not equipped to handle the complexity associated with LGBTQ issues. Until every student is reading and succeeding academically, there is simply no time to teach controversial social issues.

10) Gender Identity Instruction: Should Gender Ideology be taught or encouraged within the public school system? Why, or why not?

No, gender ideology should not be taught or encouraged within the public school system. Schools are under so much pressure to perform academically that we simply do not have time to teach gender ideology. Belief systems are matters of family, culture, and individual thought—not something any public system has the right or authority to teach.

11) Immigration Status: How should the school districts address enrollment concerning children of illegal immigrants? Is this a strain on our system that takes away opportunities from citizens and those with legal immigration status? Should additional documentation be required beyond the basic proof of address we have now?

School districts should require formal legal identification and proof of residency for access to services designed for citizens of that district. Acceptable forms of identification may include a birth certificate, visa, family green card, or foreign exchange student status, among others. Illegal immigrants may choose to homeschool or pursue other forms of education, but schools funded by the citizens of a community should serve only the citizens of that community. While in some cases illegal immigrants may place a strain on the system, in other cases they may not. Regardless, government-funded education is primarily designed for citizens. There are numerous educational opportunities in and around the community that do not require legal citizenship, such as public libraries and other organizations.

1) Purpose: What do you view as the purpose and role of the County School Board?

The County School Board’s role is to set the vision, policies, and accountability for the public school system. It hires and evaluates the superintendent, approves the budget, ensures responsible use of taxpayer dollars, and makes decisions that support student success, staff effectiveness, and safe, high-quality schools. A strong board focuses on governance rather than day-to-day management, listens to the community, and works to ensure every student has access to opportunity and a quality education.



2) Candidate's Focus/Expertise/Initiatives: What are your areas of special focus and/or expertise and what initiatives would you undertake as a County School Board member?

My focus areas are work-based learning, school safety, teacher support, and stronger family and community partnerships. As a nonprofit leader, parent, and community advocate, I have experience building programs, managing budgets, forming partnerships, and listening well to people with different perspectives.

As a County School Board member, I would work to expand career and life-readiness opportunities, support safe and positive school environments, advocate for teachers and staff, and strengthen connections between schools, families, and community partners. I would also prioritize clear communication, responsible oversight, and student-centered decisions that help prepare every student for success in school and in life.

3) Moral Values: Should government laws, ordinances, regulations, etc. follow the moral principles of the Ten Commandments? Why, or why not?

Laws and public policy should be guided by strong moral principles such as honesty, justice, responsibility, respect for others, and the protection of life and freedom. Those values help create a healthy, stable society. With any large budget, there is always room to improve transparency, efficiency, and alignment with student needs. I would want to ensure resources are being used as effectively as possible at the school level, not just absorbed by administrative costs or systems that are not delivering results. I believe strong financial oversight includes clear reporting, measurable outcomes, and regular evaluation of spending priorities. As a School Board member, I would ask thoughtful questions, support responsible budgeting, and work to ensure investments reflect district goals such as student achievement, school safety, teacher support, and career readiness. Taxpayer dollars should be managed carefully, strategically, and with accountability to both students and the community.

6) Preventing School Violence: In the aftermath of the 2023 Covenant School tragedy, Tennessee has strengthened school safety laws, but many parents continue to express concern in this area. What additional strategies or policy changes would you support in Hamilton County to prevent school shootings, foster community well-being, and protect the rights of students and staff?

I would support a balanced approach that focuses on prevention, preparedness, and strong school communities. That includes secure buildings, well-trained school resource officers, regular emergency planning, and clear communication between schools, families, and law enforcement. I also believe we must invest in mental health support, early intervention when students show signs of distress, and school cultures where students feel known, connected, and safe speaking up. Protecting the rights of students and staff means using fair policies, respecting due process, and making thoughtful decisions that build both safety and trust. School safety is not just about responding well in crisis, but about creating environments where problems are less likely to grow in the first place.

7) Sex Ed Instruction: How should the Hamilton County school district select and source materials for sex education? Should this instruction be provided in schools, strictly at home, or a combination of both? Which organizations, if any, do you believe should be restricted from providing materials, and what is your rationale?

Any instruction on this topic should be age-appropriate, fact-based, aligned with state law, and transparent to parents. Families should know what is being taught, be able to review materials, and have a meaningful voice in the process. I believe schools can play a role in providing clear, health-related information, while parents remain the primary guide for deeper personal, moral, and family-based conversations. That makes a combination approach the most reasonable. Materials should be selected through a careful public review process focused on educational value, medical accuracy, and age appropriateness. Organizations that provide materials inconsistent with state standards, lack transparency, or push ideology over student well-being should not be used.

8) Racial equity: How should the school district approach teaching racial equity, and what role, if any, should diversity, equity and inclusion play in the curriculum?

Schools should teach students to understand history honestly, treat others with dignity, and learn how to work with people from different backgrounds and experiences. Every student should feel respected, supported, and able to succeed. In the classroom, the focus should remain on strong academics, critical thinking, character, and preparing students to live and work in a diverse world. Diversity, equity, and inclusion should not be about politics or division, but about fostering belonging, fairness, and opportunity for all students. The goal is not to separate students by differences, but to ensure every child is seen, valued, and given the support needed to thrive.

9) Instruction of LGBTQ Issues within Schools: How should Hamilton County schools approach teaching topics related to LGBTQ issues?

Schools should approach these topics in a way that is age-appropriate, respectful, and aligned with state law and district policy. The primary focus of schools should remain on academics, student well-being, and creating safe environments for all students. Parents should be informed, have transparency into instructional materials, and remain an important part of conversations involving sensitive topics. Schools should teach students to treat one another with dignity and respect, and staff should work to ensure that every student feels physically and emotionally safe. These issues should be handled thoughtfully, without political agendas, and in a way that supports both parental involvement and a positive learning environment for every child.

10) Gender Identity Instruction: Should Gender Ideology be taught or encouraged within the public school system? Why, or why not?

Public schools should not be in the business of promoting ideology. Their role is to educate, support student well-being, and maintain a safe, respectful learning environment for every child. Sensitive topics related to identity should be handled carefully, in age-appropriate ways, and with transparency for parents. Schools should focus on academics, character, and helping students treat one another with dignity and respect. Parents should remain the primary voice in deeply personal matters involving values and identity. The goal should be to create schools where all students are safe, supported, and able to learn, without crossing the line from education into advocacy.

11) Immigration Status: How should the school districts address enrollment concerning children of illegal immigrants? Public schools are required to serve children who live in the district, and schools should follow the law while maintaining clear, consistent enrollment procedures. The focus should be on verifying residency and ensuring that students who are enrolled actually live within the district. At the same time, schools must remain focused on their educational mission and avoid putting staff in the position of handling federal immigration matters. If there are concerns about strain on resources, the district should address them through better planning, enrollment tracking, and advocacy for adequate state and local support.

1) Purpose: What do you view as the purpose and role of the County School Board?

School board members set policy, approve budgets, and hire and evaluate the superintendent. HCDE Board Policies also include promoting school-community communication, conducting self-evaluations, staying up-to-date with state legislation that impacts our schools, and voting impartially for the good of the school system. All of these responsibilities exist to ensure that every decision the board makes supports the ability of students to learn, grow, and succeed.

A national review of more than 2,800 school districts found that higher-performing boards are associated with stronger student outcomes, including higher graduation rates and improved achievement. These boards focus on clear goals, use data to monitor progress, align resources with priorities, and work collaboratively with the superintendent and community to support student success.

2) Candidate's Focus/Expertise/Initiatives: What are your areas of special focus and/or expertise and what initiatives would you undertake as a County School Board member?

As a mother of two public school students and a university educator with 15 years of teaching experience, I bring both a parent's perspective and professional expertise in education. I teach courses in developmental psychology, career and professional development, statistics, and research methods—all directly relevant to evaluating educational programs and student outcomes.

My research includes publications on teaching effectiveness, student success, and career readiness. I train educators across the country on evidence-based teaching practices. I also conduct community outreach and parent workshops on sexual assault prevention and child safety.

As a school board member, I will focus on data-informed decision making, supporting educators, strengthening student well-being and safety, and preparing students for success after graduation.

3) Moral Values: Should government laws, ordinances, regulations, etc. follow the moral principles of the Ten Commandments? Why, or why not?

The moral principle and commandment that has had the biggest impact on who I am as an educator, psychologist, and mother is, "This is my commandment, that you love one another as I have loved you" [John 15:12]. This commandment will also guide my work on the school board.

Board members are required to follow a code of ethics that emphasizes integrity, transparency, and avoiding conflicts of interest in decision making. For me, these align well with faith-informed moral values such as honesty, justice, responsibility, respect, and caring for others. Additionally, school board members are sworn to uphold the Constitution and the laws of Tennessee.

4) Parental Rights: What is the best way to involve parents in the student's education? Who do you believe is the most important stakeholder in a student's education?

Students do best when families and schools work together. More than 100 studies conducted over the past two decades report that more parental involvement is associated with better student academic achievement and school engagement. Research also shows that when parents communicate expectations about education and stay engaged with their child's learning, students have higher academic motivation, achievement, and emotional well-being.

According to the experts, the best way to involve parents is through clear communication, accessible school events, and opportunities for families to participate in learning both at home and at school. Parents are the most important and enduring influence in a child's life and should always be treated as partners and respected in educational decisions.

5) Finances: Education is the largest budget item in Hamilton County. In what areas do you see room for improvement in its management, and how would you address these challenges?

According to the 2025 Chamber of Commerce, Hamilton County Schools is the second largest employer in the county, employing 6,116 people (more than Volkswagen). HCS operates with a budget of roughly \$692 million, with the largest share supporting the salaries of teachers and staff who work directly with students. Unfortunately, recent analyses show that many teachers are earning less this year than last year, even as the cost of living has increased.

The current board and superintendent have worked to make responsible decisions, but rising costs and limited revenue have created challenges and budget deficits. Moving forward, I support transparent budgeting, prioritizing classroom resources, and advocating for funding from our County Commission to help recruit and retain excellent educators.

6) Preventing School Violence: In the aftermath of the 2023 Covenant School tragedy, Tennessee has strengthened school safety laws, but many parents continue to express concern in this area. What additional strategies or policy changes would you support in Hamilton County to prevent school shootings, foster community well-being, and protect the rights of students and staff?

I experienced an active shooter hoax at UTC last fall. One of the things I appreciated about UTC's response was the training faculty and staff received afterwards. HCS policy currently requires drills, including one annual intruder drill and CPR/AED training, but does not require the hands-on bleeding control or active threat response training that saved lives at The Covenant School.

Research shows preparedness varies widely and schools often overestimate readiness without concrete training, equipment, and coordination. I will advocate for expanding our policy to include active threat response training, Stop the Bleed training, and accessible trauma kits in every school. Prevention must also include threat assessment teams and strong mental health supports, which have been shown to reduce risk.

7) Sex Ed Instruction: How should the Hamilton County school district select and source materials for sex education? Should this instruction be provided in schools, strictly at home, or a combination of both? Which organizations, if any, do you believe should be restricted from providing materials, and what is your rationale?

Sex education should be a partnership between schools and families. Given Tennessee's public health data, this matters. Tennessee ranks among the top 10 for teen birth rates; Hamilton County has an average of 19.5 births per 1,000 compared to 16.7 nationally. Our teens also face elevated risks for STIs. Research shows that programs including contraception education are associated with higher contraceptive use and (importantly) lower rates of sexual activity among youth. At the same time, approximately 59% of parents support teaching effective contraception in schools.

School boards must ensure instruction follows Tennessee law and uses materials that are age-appropriate, medically accurate, and evidence-based. When evaluating partners, my focus would be on accuracy and effectiveness, not politics.

8) Racial equity: How should the school district approach teaching racial equity, and what role, if any, should diversity, equity and inclusion play in the curriculum?

Our schools should teach accurate history and help students understand the diverse society in which they live. Tennessee law allows schools to teach about historical racism and discrimination when presented objectively. Researchers have found these topics already arise in classrooms. A national survey of 2,531 public school teachers by the Pew Research Center found that 56% report discussions about racism or racial inequality come up in class. At the same time, about 4 in 10 teachers say debates about what schools should teach have negatively affected their ability to do their job.

Local school boards should focus on ensuring instruction follows state standards, is age-appropriate, and is transparent to parents, while keeping schools focused on student learning.

9) Instruction of LGBTQ Issues within Schools: How should Hamilton County schools approach teaching topics related to LGBTQ issues?

Part of running for this position means understanding the boundaries of this role and the reach of our school board. Curriculum decisions regarding specific topics are largely determined through state standards and federal law, rather than local school boards. At the local level, our responsibility is to ensure schools follow the law, communicate clearly with parents, and maintain safe learning environments. In Tennessee, state law requires parent notification and consent before instruction specifically about sexual orientation or gender identity.

Regardless of policy debates, schools must ensure every student is treated with dignity and protected from bullying or harassment so they can focus on learning.

10) Gender Identity Instruction: Should Gender Ideology be taught or encouraged within the public school system? Why, or why not?

This is a question where people often have strong and differing perspectives. Public schools are not tasked with promoting specific beliefs; they are required to follow state standards and focus on student learning and well-being. As noted in my previous response, Tennessee law already sets parameters around instruction related to sexual orientation and gender identity.

The role of a local school board is to ensure policies are implemented appropriately, parents are informed, and classrooms remain focused on academics.

Regardless of differing views, every student should be treated with dignity and be able to learn in a safe environment. My goal is to listen to and represent all voices in our community within the scope of this role.

11) Immigration Status: How should the school districts address enrollment concerning children of illegal immigrants? Is this a strain on our system that takes away opportunities from citizens and those with legal immigration status? Should additional documentation be required beyond the basic proof of address we have now?

Public schools are required under federal law (e.g., Plyler v. Doe) to provide free education to all children regardless of immigration status. Local school boards must follow that law. Recent Tennessee legislation (HB 793/SB 836) would require schools to collect and report students' immigration status.

No child is currently being turned away from our schools. Under TISA, funding is allocated on a per-student basis, meaning each student enrolled brings resources to support their education.

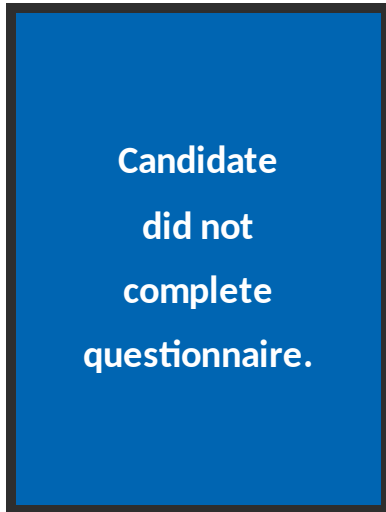

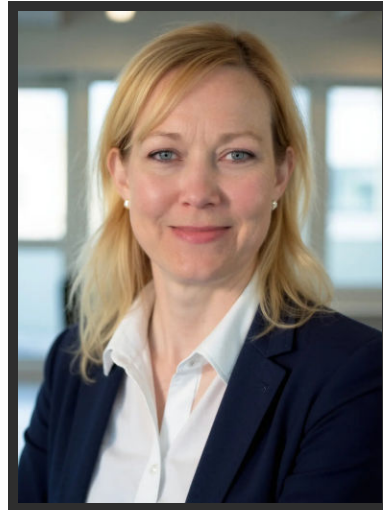

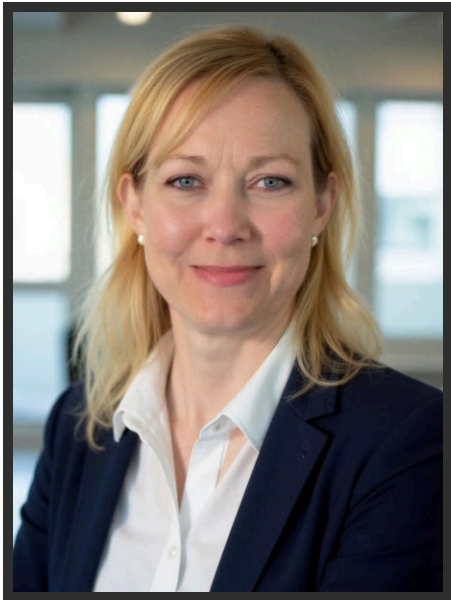

Fiscal transparency means scrutinizing the district budget like a private business—ensuring every TISA (Tennessee Investment in Student Achievement) dollar directly impacts student outcomes rather than administrative overhead. Curriculum transparency ensures parents are empowered partners with frictionless access to all classroom materials. My expertise lies in replacing bureaucratic ambiguity with clarity and trust, ensuring our schools prioritize the families they serve and the taxpayers who fund them.

3) Moral Values: Should government laws, ordinances, regulations, etc. follow the moral principles of the Ten Commandments? Why, or why not?

As a conservative parent of two daughters and a business owner, I believe our laws and schools must reflect the foundational moral principles that built our nation. Values like honesty, integrity, and respect—the core of the Ten Commandments—are not just religious; they are the bedrock of a stable society and a successful business. My commitment is to Fiscal and Curriculum Transparency. I will ensure your tax dollars are managed with business-like accountability and that parents have access to all classroom materials. 5) Finances: Education is the largest budget item in Hamilton County. In what areas do you see room for improvement in its management, and how would you address these challenges?

Education is Hamilton County's largest budget item, yet it remains "top-heavy" while starting teacher salaries (roughly \$40,000–\$44,000) lag significantly below the national average. I will implement a "Classroom First" mandate, requiring 65-70% of all new revenue to fund teacher salaries and supplies before any new administrative roles are created. Additionally, inflationary pressures have turned deferred maintenance into a "money pit." Instead of simply asking for more taxpayer money, I would call for a Third-Party Efficiency Audit to find savings in procurement and vendor contracts. Through Radical Fiscal Transparency, I will ensure TISA funds directly impact student outcomes, prioritizing our children's proficiency over bureaucratic growth.

6) Preventing School Violence: In the aftermath of the 2023 Covenant School tragedy, Tennessee has strengthened school safety laws, but many parents continue to express concern in this area. What additional strategies or policy changes would you support in Hamilton County to prevent school shootings, foster community well-being, and protect the rights of students and staff?

In Hamilton County, parents are no longer satisfied with "compliance"; they want visible, proactive protection. I fully support the 2024 state law allowing for highly trained, transitioned SROs or vetted staff members to be armed, provided they undergo rigorous, ongoing tactical and psychological training. No school should ever be a "gun-free zone" that leaves children defenseless. Fostering community well-being requires trust, which is broken when security measures infringe on student privacy or staff rights. I would propose that each school has a dedicated Safety Liaison whose only job is to communicate safety protocols to parents. Parents should not be left in the dark, they should be partners in the safety plan.

7) Sex Ed Instruction: How should the Hamilton County school district select and source materials for sex education? Should this instruction be provided in schools, strictly at home, or a combination of both? Which organizations, if any, do you believe should be restricted from providing materials, and what is your rationale?

Hamilton County should source materials through Radical Transparency, ensuring all curriculum is vetted by the Board and fully accessible to parents online. I believe sex education is primarily a sensitive, moral conversation that belongs at home. While schools can provide basic, medically accurate biological instruction, it must remain an "opt-in" model, respecting the Parent as the most important stakeholder. I believe organizations with political or ideological agendas, should be restricted from providing materials or instruction. The rationale is simple: public schools must focus on objective academics, not social engineering. By removing outside activists and providing transparency, we hold the system accountable and empower parents to remain the constant authority in their children's lives.

In Hamilton County, my approach is Equality of Opportunity, not Equity of Outcome. As a parent with a bi-racial daughter, I flatly refuse any curriculum that suggests she should be held to a lower standard or viewed through the lens of victimhood. Our schools must focus on Merit-Based Excellence, teaching the full, honest history of our nation without assigning collective guilt or "divisive concepts" prohibited by Tennessee law. Through Radical Transparency, I will ensure parents have digital access to all materials to verify that we are graduating independent thinkers judged by the content of their character. DEI frameworks that prioritize group identity over individual accountability have no place in our classrooms; we must demand the highest standards for every student.

9) Instruction of LGBTQ Issues within Schools: How should Hamilton County schools approach teaching topics related to LGBTQ issues?

Hamilton County Schools should be advocating for classroom time to be spent on core academic subjects—math, reading, and science—while leaving sensitive social and sexual topics to the home. There should be privacy and safety for all students. I support the maintenance of sex-segregated private spaces (bathrooms, locker rooms, and overnight field trip accommodations) based on biological sex to ensure the comfort and security of the student body. Tennessee law (SB 1810 / HB 2169) now mandates a high level of transparency regarding a student's gender identity. The school should never withhold information about a child's mental or emotional well-being from their parents.

10) Gender Identity Instruction: Should Gender Ideology be taught or encouraged within the public school system? Why, or why not?

There are several reasons I oppose teaching gender ideology in the curriculum. First, I believe that questions of identity, morality, and sexuality are the sole domain of the family. When schools "encourage" specific gender ideologies, they are overstepping their role and effectively "co-parenting" with the government. Second, many families hold deeply religious or traditional views on biology. Introducing gender ideology as "settled fact" creates a hostile environment for students who hold differing beliefs, violating the school's duty to remain ideologically neutral. Schools are not clinical environments. Encouraging children to question their biological sex without full parental involvement is a liability for the school and a risk to the child's long-term well-being.

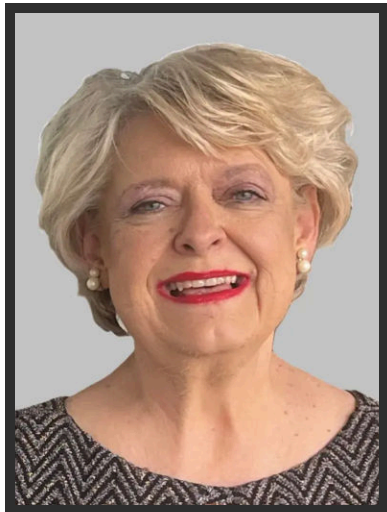

I appreciate the paideia philosophy that CSAS and CSLA have been using for many years. This type of learning is a holistic, classical Greek philosophy of education aimed at shaping the whole person—mind, body, and character—to create well-rounded citizens. It focuses on rigorous, liberal arts education for all students, fostering critical thinking, lifelong learning, and active civic participation through a three-columned approach: didactic instruction, coaching, and Socratic seminars. With this philosophy students are able to discuss among themselves roles topics like racial equity. This is important because students discuss with their peers, who may be of different race, about their understanding of these topics and about life experiences.

9) Instruction of LGBTQ Issues within Schools: How should Hamilton County schools approach teaching topics related to LGBTQ issues?

Public schools are inclusive environments. These environments represent real life, outside of school. Again, the paideia philosophy would be a good way to handle this. Students from different backgrounds, who have different life experiences should have discussions with open minds and open hearts and listen to one another. Compassion and tolerance are the highest forms of education.

Also better more current equipment such as those used in athletic and entertainment events can also help. There are federal and private grants available for both equipment and software for systems.

Improved lighting in all areas including parking lots and other facilities will help.

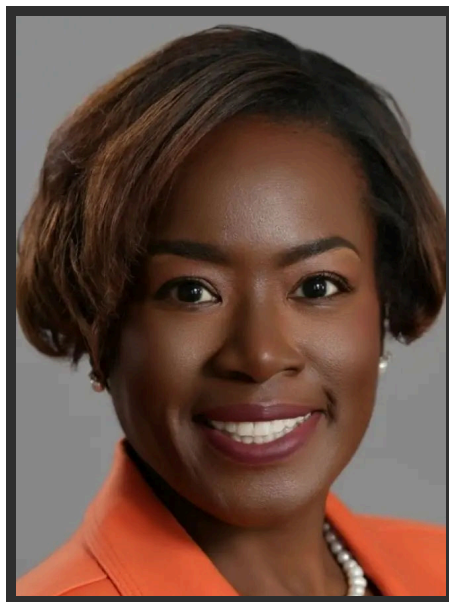

1) Purpose: What is the purpose and role of the Criminal Court Clerk, and what values and expertise should the candidate possess?

The role of the Criminal Court Clerk is multi-faceted. The clerk is charged as the keeper of the records for all criminal court cases, both at the Session's level and the State Criminal Courts. He or she is also charged with collecting the fees and fines, as ordered by the court. The clerk oversees as well as manages the \$5 Million annual budget, as well as the 60 Deputy Clerks. It is essential that the Criminal Court Clerk shows competent leadership skills and also has the ability to manage a budget.

2) Candidate's Focus/Expertise/Initiatives: What are your areas of special focus and/or expertise and what initiatives would you undertake as Criminal Court Clerk?

Since taking office, I have used my leadership skills to assemble a team of some of the best deputy clerks this county has ever seen. In rare occurrences we have found it necessary to sever ties with deputy clerks that did not adhere to our standards. We have done that without apology, as we recognize that we serve the public. We have managed our budget and stayed within the confines of our "letter of agreement" with the Mayor's office each year since taking office. We created a payment center making it easier and more convenient for citizens that owed court fines in both the Session's and State Criminal Offices. We did the same thing with our expungement center.

3) Moral Values: Should government laws, ordinances, regulations, etc. follow the moral principles of the Ten Commandments? Why, or why not?

Absolutely! the Ten Commandments were given to Moses at Mount Sinai and should be the foundation for all laws and ordinances. More than anything I am a firm believer that this would be a wonderful world if all citizens would adopt the Ten Commandments as guide for their lives.

4) Community Impact: Describe why this position should be taken seriously by voters, how it meaningfully impacts the integrity and effectiveness of the criminal justice system, and what you believe voters may misunderstand or overlook about its importance.

While the majority of voters will never set foot in any of our offices or even in any of our courts, their tax dollars certainly can. It is imperative that the Criminal Court Clerk has a history of being able to manage funds both personally and professionally. It is also vital to have a good leader that can discern good employees from bad. An effective leader must be able to separate the wheat from the chaff. Then they must be able to rise above the criticism of those whose employment is terminated. I must be able to lay my head down each night and I certainly can.

5) Fiscal Responsibility: How can the management of the Criminal Court Clerk's office save taxpayer dollars or, if mismanaged, result in unnecessary costs?

Poor fiscal responsibility can lead to funds being diverted from the general fund (taxpayer dollars) to the budget of this office. Very simply, if the Clerk cannot manage the budget, the taxpayers are left to make up the difference. It is also vital that the clerk choose the right employees and be able to recognize their talents and place them in the most productive positions. There are many different jobs to be performed in this office and not everyone is suited for every job. Strong leadership skills ensure strong job performances by the appropriate deputy clerks.

6) Balancing Transparency and Justice: Do you agree with public posting of those arrested in local news sites or publications as a deterrent to criminal activity? Explain the pros and cons of such a policy.

While I may have my own personal opinion about this, that is exactly what it is: my personal opinion. My office does not provide or own any mugshots. Those are property of the Sheriff's Office. We do maintain the arrest records, which are public record. Whether I believe the publication of such is a deterrent is irrelevant. The law says that such information can be published and local media outlets make the determination as to whether or not they are published. Again any change to such would need to be done by the Tennessee General Assembly. We are charged with following the law.

7) Interstate Probation Tracking: How should probation records be shared between states and jurisdictions to ensure individuals on probation are effectively monitored if they relocate?

My office does not handle probation issues. They are handled by The State office of Probation for the State Court cases and by Hamilton County probation office for Session's court cases.

8) Addressing Delinquent Fines: Should asset confiscation or other measures be considered for individuals delinquent in paying criminal fines? Please explain your reasoning.

There are many schools of thought on this. In some smaller counties, asset confiscation has been used. However, in a county our size it would be almost impossible to utilize this measure. When I first took office we tried to garnish employment pay. We quickly found that when a defendant was garnished at Wendy's they would quit and go work at McDonalds. We have had good success with our collection agency. We also work closely with defendants to be on a payment plan and retain their drivers license. A large number of our customers are indigent, as determined by the court. They frankly don't have any money. We deposit around \$6 million per year. More than our budget.

9) Efficiency through Technology: How can technology be used to reduce costs and improve efficiency in managing records and documentation for criminal proceedings?

Our office has been on the cutting edge of this issue. We developed an APP for the judicial system in Hamilton County. Citizens can find court dates, dispositions and most of our records that are public. We partnered with V.I.N.E. (Victim Notification Everyday) where defendants and interested parties are notified of upcoming court appearances. V.I.N.E. has helped reduce our FTA (Failure to Appears) drastically, thus reducing the number of defendants arrested and incarcerated until court. We have developed a QR code to allow defendants with cases dismissed to apply for expungement without coming into our office. Electronic submission of court requirements ordered by a judge is now available. More that 120 words don't permit.

Because the Criminal Court Clerks Office is funded by the collection of fines and costs of the defendants use of the legal system, and other funds provided to this office from the County Government that cover salaries, supplies etc., as with any business, the management of this office is to ensure all areas function as financially responsible as possible; and of course, mismanagement of funds and resources will result in finding and/or asking for funds to meet shortfalls and the possible dismissal of employees; which of course will effectively affect office performance and function.

I am undecided: after all the years working for the Criminal Court Clerks Office, I am not decided whether publicly posting arrests in local news sites or publications is good or bad. Of course it is a deterrent; however, we continually have people committing the same offenses daily or until they are caught; even while working for the office, the cases and people I saw and heard were deterrent enough for me personally. So I will suggest that the consequence of Public Humiliation, loss of employment and public judgment following any arrest is deterrent enough; and maybe seeing a friend or family member in a precarious position is the payoff.

7) Interstate Probation Tracking: How should probation records be shared between states and jurisdictions to ensure individuals on probation are effectively monitored if they relocate?

Presently, the probation records are shared via court to court or probation office to probation office; in the event a defendant is allowed, by a Judge, to relocate across town or another state; however, in the event the defendant is or does not adhere or violates his/her probation order, a warrant of arrest is then Issued for the defendant wherever he/she may be found, and effectively causing that person to be remanded to the probation issuing jurisdiction. This is about the most effective assurance existing. Any other ideas or implementations must discussed with the local probation office, Judges and Clerks Office.

8) Addressing Delinquent Fines: Should asset confiscation or other measures be considered for individuals delinquent in paying criminal fines? Please explain your reasoning.

When Letter notification, follow up letters and possible phone calls do not cause payment of fines and costs to the court, yes asset confiscation should be allowed, but not without exhausting all notification effort(s). The person and/or defendant(s) are made aware and given a copy of fines and costs incurred, before leaving custody; they are tasked with an in court review date to verify that fines and costs are being paid. The only time assets are confiscated is when the account reaches non-payment or delinquent status is usually due to the defendant having relocated, deceased or both; therefore, continued payment to keep the office in compliance and on budget is a necessity.

9) Efficiency through Technology: How can technology be used to reduce costs and improve efficiency in managing records and documentation for criminal proceedings?

By attending all or most conferences, Judges, Public Defenders and District Attorneys, the Clerks Office would be able to hear and see what each aspect of the judicial process is responsible for in the Legal, Judicial Process, we would be better able to find, enhance or even create technology that would reduce time, cost, function, documentation and management of records; thus effectively enhancing efficiency. At present, the clerks office functions according to its best level, but with attendance to conferences and possibly initiating a clerk's conference will make our offices and work exceptional.

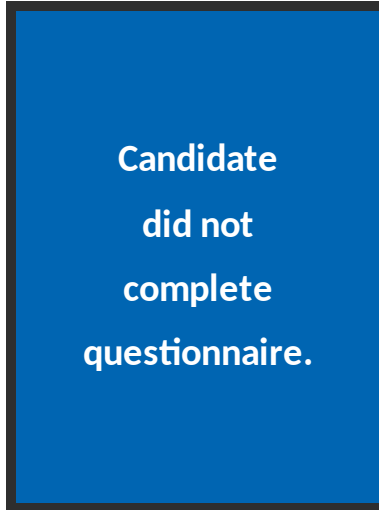

This additional financial burden could lead to higher taxes or cuts in other essential services. We should work to de-incentivize reasons illegals want to come to Tennessee.

Tennessee should protect assistance programs for those who genuinely need them while aggressively preventing fraud. I support requiring regular independent audits, real-time eligibility verification, cross-checking income, residency, incarceration and death records, and stronger data-sharing among agencies. High-risk payments should receive additional review, and agencies should publicly report improper payments, recoveries and corrective actions. Tennessee should also strengthen whistleblower protections, pursue repayment and prosecution for intentional fraud, and hold contractors accountable for weak controls. Ideally, progesterone treatment—commonly known as abortion-pill reversal—should be more readily accessible through emergency medical providers and pharmacies, with appropriate medical guidance and clear information about its potential benefits, risks, and limitations.

Yes. Every vote should produce a voter-verifiable paper ballot that can be independently audited. I support bipartisan chain-of-custody procedures, continuous video recording wherever ballots are received, transported, stored, opened, duplicated or counted, and timely public access to those recordings—with safeguards for voter privacy and ballot secrecy. I would also require documented seal checks, public observation, retention of ballot images and audit records, and stronger post-election audits comparing paper ballots with electronic totals. Candidates should have a clear, affordable process to request a hand count when results fall within a defined close-election threshold or documented irregularities exist. Transparency must be built into every stage so voters do not have to simply trust the technology or the officials administering it.
